## Bid Requirements:

**Preliminary:** Must have hosted at least a sanctioned meet within the last two (2) years. Must be in good standing with the State Administrative Committee. Host required to accept 150 entries per day or minimum of 300 per weekend.

**Sectional:** Must have hosted one (1) or more prelims within the last four (4) years successfully: i.e. facility and equipment meet specs, meet schedule & awards on time, fees paid (competition fee & awards). Must be in good standing with the State Administrative Committee.

**State:** Must have hosted at least one (1) Sectional within the last five (5) years successfully (see sectional description above). Facility must accommodate 200 gymnasts and 400 spectators per day and gym set-up **must meet R & P specs** in addition to the normal. Second set of equipment may be required. Host must be in good standing with the State Administrative Committee.
